**Re : Chinese Taipei Olympic Committee & Ms. LIN Yu-Ting**

Dear Sirs,

As legal counsel to Chinese Taipei Olympic Committee, we wish to draw your attention to a serious issue involving your potential actions concerning the disclose of the personal data and information of Ms. LIN Yu-Ting, a female athlete of Chinese Taipei competing at the Olympic Games 2024.

This letter serves as a formal demand for you to immediately cease all such inappropriate act and conduct.

It has come to our client's attention that your Association may organize tomorrow an international press conference to reveal Ms. LIN's personal examination results and information.

We remind you that these actions are unlawful and violate the regulations of personal data protection which may cause the loss and damage to our client's and Ms. LIN's rights and reputations.

In addition, according to the Joint Paris 2024 Boxing Unit/IOC Statement issued on 01 August 2024,

- All athletes participating in the boxing tournament of the Olympic Games Paris 2024 comply with the competition's eligibility and entry regulations, as well as all applicable medical regulations set by the Paris 2024 Boxing Unit (PBU).
- Ms. LIN was the victim of a sudden and arbitrary decision taken by your Association in 2023 without any proper procedure.

- your Association's recognition was withdrawn by the IOC in 2023 following its suspension in 2019. The withdrawal of recognition was confirmed by the Court of Arbitration for Sport (CAS).

Given the above, your question in Ms. LIN's female gender has no legal grounds and therefore invalid.

Please cease immediately your wrongful act. Failure on your part to do so, our client reserves all rights to take legal actions against your Association.
